**Regular Meeting of PIAA District 6 – August 1, 2018**

**Call to Order of the August 1, 2018, Meeting**

On a motion by Lori Ratchford and Kim Hubler, unanimously approved St. Joe's to initiate a program Boys/Girls Varsity Soccer effective immediately.

On a motion by Kenneth Kerchenske and Jody Rainey, the Committee unanimously granted Portage Area to add a Junior High Cross Country and Claysburg Kimmel to Co-op boys and girls Junior High Soccer with Chestnut Ridge.

On a motion by Jody Rainey and Lori Ratchford, the Committee unanimously agreed that in the matter of recruiting allegations made against the Bishop McCort athletic program, District 6 considers this matter closed. Bishop McCort provided a detailed summary and explanation of the actions of their employees named in Mr. Andrews letter. The students and parents named in Mr. Andrews letter were contacted and none wished to make any comments to our Committee. Therefore, the District 6 Committee considers Mr. Andrews accusations unfounded.

On a motion by Michael Hudak and Charles Glasser, the Committee appointed Rudy McCarthy to serve a three term as the Male Parent Representative. The vote was 13-0-1.

### **Informational Items**

Kim Hubler will fill Ralph Cecere's vacancy at the executive meeting.

Background clearances will be needed for ALL District 6 Committee members who are not involved in public schools or officiating.

Possibility of doing away with presale tickets and using Ticket Tap, an electronic ticket online ordering system.

There is a possibility that District 6 may have to contribute to PIAA litigation costs.

New Transfer Rule will be effective August 6, 2018. The new rule will only affect 10<sup>th</sup>, 11<sup>th</sup>, and 12<sup>th</sup> graders.

D6 Pitch Count Manager – someone will be paid to count pitches at districts, not regular season games.

Eligibility Web Portal will be active 2018/19 and Training videos on line by July 1
