Athletic Directors and Principals: Please be mindful of the PIAA maximum contest regulations per sport seasons when considering participation in any tournament. A recent Junior High "District" competition that has been communicated to selected schools, could compromise your PIAA catastrophic insurance coverage and possibly your own school district insurance policy. Open tournaments must be club driven, school uniforms are not permitted, school names are not permitted, scores do not count towards a team, etc. Upon request, District VI may allow for junior high league championships that do not count for total competition points and is covered by the catastrophic insurance policy of PIAA but a junior high wrestling championship was not approved. Be careful to disassociate your school with tournaments of this nature and consult with your solicitor if necessary.
