## Call to Order of the March 14, 2006 Meeting

## Approval of Minutes

On a motion by Kenneth Bussard and Dean Rossi the minutes of the February 9, 2006, meeting was approved.

## Financial Reports

On a motion by Susan Werner and Michael Hudak, the Committee unanimously approved the February financial report.

On a motion by James Price and Thomas Kakabar, the District 6 Committee will reimburse Chairman Ray Wotkowski for refreshments served at the basketball championships and consistently provide refreshments for the school personnel, officials and committee members in attendance.

## Communications

Chairman Wotkowski received a letter from Dr. Richard C. Makin, Superintendent at Purchase Line School District, and Mr. Scott King, Superintendent of Harmony Area School District, requesting to dissolve the cooperative sponsorship agreement for football. On a motion by Thomas Kakabar and Kim Struble, permission was granted to dissolve the agreement with a vote of 14-0-1. James Price abstained from voting.

On a motion by James Price and Norman Krumenacker, the District 6 Committee agreed to extend the AAAA basketball play-off deadline to include all 24 games.

On a motion by Norman Krumenacker and Michael Hudak, the District 6 Committee will support playing sports by gender when both are offered at member schools. The various sports chairmen and other special interest members will consistently support this position while attending workshops.

Chairman Wotkowski received a letter from Ronald Pavlechko, Athletic Director at State College informing the District 6 Committee of 14 match forfeitures in wrestling due to the use of ineligible contestants at the 112 pound and 119 pound weight classification in the varsity wrestling contest between State College and Bald Eagle High School on January 10, 2006. On a motion by Albert D'Ambrosia and David Crumrine, Chairman Wotkowski will write a letter requesting State College to investigate, provide evidence of the course of action taken, and report the course of action taken to the District 6 Committee.

Chairman Wotkowski received a letter from Diane Price, Athletic Director at Juniata Valley School District, informing the Committee that Juniata erroneously scheduled one extra wrestling match; that match will be forfeited. On motion by Charles Koren and Michael Hudak, Chairman Wotkowski will write a letter requesting Juniata to investigate and report to the District 6 Committee, in writing, how this occurred and the course of action taken.

Chairman Wotkowski received a letter from Stuart Albaugh, Principal at Ferndale Area, on an incident that occurred on February $15^{\text {th }}$ during a boy's basketball game with Blacklick Valley. On a motion by Michael Hudak and David Crumrine, Chairman Wotkowski will write a letter requesting Ferndale to specifically report to the District 6 Committee, the specific course of action taken to address this sportsmanship concern.
