### Call to Order of the March 7, 2019, Meeting

Curt Whitesel updated the Committee on the effort to save costs in the future for Swimming/Diving and to expect the expense report in May or June.

William Marshall informed the Committee on some of the Basketball financials, highlighting that it lost money on two contests.
