Chairman Wotkowski shared the contacts of a new weekly newspaper, Our Town, with the committee.

On a motion by Don Hosterman and Vince Nedimyer the Committee voted unanimously, that re-seeding of wrestling teams will no longer take place once the tournament has started beginning with the 2007 team wrestling tournament.

Attendance at the spring meeting was discussed with several suggestions offered for increasing the number of member schools attending. Please forward suggestions to any board member.

Spring sports reports were given. Charles Koren went on record thanking Dean Rossi and the Tennis Tournament Chairman for flexibility in working with students taking the Advanced Placement test.

The Budget Committee of Don Hosterman, Dean Rossi, Thomas Kakabar and Michael Hudak will meet and evaluate current fees and salaries.

On a motion from Don Hosterman and Dean Rossi the Committee unanimously accepted Juniata Valley's written explanation of forfeiture of a wrestling match.

On a motion from Craig Butler and Charles Koren, the Committee unanimously accepted a probation report from Richland High School.

On a motion from Jim Price and Albert D'Ambrosia the Committee unanimously accepted, with one member abstaining, a probation report from Bishop McCort.

On a motion from Charles Koren and Michael Hudak, the Committee unanimously accepted a letter from Ferndale Senior High in response to concerns that surfaced during the course of this 2005-2006 Boys Basketball season.

Sportsmanship Awards will be formalized at the June meeting.

The following schools were fined \$100 for failure to attend the mandatory rules meetings: Track and Field-Bishop Carroll, Central Mountain, Laurel Valley, Bishop Guilfoyle, Somerset and Philipsburg-Osceola.

A discussion of a request for a volleyball power rating was tabled until the June meeting.

On a motion from Dean Rossi and Charles Koren, Bellwood-Antis will be asked to report in writing concerning a baseball forfeit.

Vince Nedimyer reported that the Football Subcommittee has met and will reconvene on Wednesday, May 17<sup>th</sup> 2006.

Mike Hudak reported that Blairsville and Penn Cambria have successfully completed and satisfied all of the probationary conditions of their boy's basketball programs. On a motion from Mike Hudak and Sue Werner, the committee unanimously accepted the report.
