## Call to Order of the November 2, 2011, Meeting

## Approval of Minutes

On a motion by Kenneth Bussard and Norman Krumenacker, the minutes of the October 5, 2011, meetings were approved.

## Financial Reports

Thomas Kakabar and Kenneth Bussard made a motion to approve a boys and girls basketball championship request from Laurel Highlands. Motion was passed with a vote of 9-0.

A motion was made by Curtis Whitesel and David Crumrine to approve the cooperative sponsorship of a sport across school district boundaries, effective for the 2010-2012 school years for boy's tennis and boy's golf between Juniata High School and East Juniata High School.

A motion was made by William Marshall and Kenneth Salem to make the recommendation to adopt guidelines for the 2012/2013 cycle to include 2 scrimmages, 9 regular season scheduled games, and 8 game championship tournaments for class A and AA schools, passed by 11-2 vote.

- Third and final reading of the football decision will be acted upon at Board of Directors meeting on December $7^{\text {th }}$.

A motion was made by Kenneth Bussard and Thomas Kakabar to deny the request from Juniata Valley to move the Single A playoff football game from Saturday to Friday because of the Penn State home game. The vote was 9-0.
